President Caboni refers to the need for the board to review the mission statement on a regular or semiregular basis and also to be reminded of what the mission statement is. Dr. Laves discussed the principles of accreditation for the reaffirmation for SACSCOC, and she showed the board the slide that listed the WKU mission as:

Western Kentucky University (WKU) prepares students of all backgrounds to be productive, engaged, and socially responsible citizen-leaders of a global society. The University provides research, service, and lifelong learning opportunities for its students, faculty, and other constituents. WKU enriches the quality of life for those within its reach.

President Caboni explained that this mission statement guides the University and "from that flows the strategic plan, the work of the faculty and staff, and all the work that we do to shape the University and elevate it." He said it is a broad mission so every person associated with WKU can see themselves as active participants.

Chair Bale mentioned the self-assessment process of the board and informed the board members that the following week they would receive an email from institutional research with a link to a survey with some questions to allow the board to evaluate itself. He said that later in the year the board would talk about and review the results of the survey. He said that he hoped it would allow the board to find ways individually and as a board to be more effective at their jobs.
