Title: Graduate Student Ambassador

Department: The Graduate School

Reports to: Associate Provost and Dean of the Graduate School

Purpose of the Position:

The Graduate Student Ambassador will serve as a liaison for all academic departments and student organizations. Ambassadors will also serve as a resource to prospective and admitted graduate students.

Primary Duties and Responsibilities:

Ambassadors will be appointed for one year and dedicate approximately 10 hours per week to their position. The following specific duties are customary for this position, but are not to be construed as all-inclusive. Duties may be added, deleted, and assigned based on supervisor discretion and institutional needs.

- Assist with graduate student outreach, recruitment, and admissions efforts
- Develop innovative communication strategies for distant learners, prospective students, and current students
- Assist with planning and implementation of social events and social media communication (Facebook, Twitter, LinkedIn, etc.). Serve as a member of the Graduate Student Advisory Council and provide insight on how to better serve the graduate student population
- Conduct tours for prospective students and attend recruitment events
- All other duties as assigned by Associate Provost and Dean of the Graduate School

Required Qualifications:

- Graduate student for at least one year (preferred)
- Must be a degree-seeking student
- Minimum GPA of 3.2
- Demonstrated ability to relate to under-represented populations of graduate students
- Excellent organizational and cross-cultural communication skills
- Evidence of excellent presentation skills

Award:

\$1500 Scholarship, Research Grant or Travel Grant awarded in Fall and Spring

Interested candidates must submit a cover letter expressing interest in the position and documenting qualifications, a current resume or CV, and names, addresses, email addresses, and daytime phone numbers of three professional references.
