- 2.3 Rationale for revision of course number: Confusion often arises about the relationship between MATH 116 and its enhanced version, MATH 116E. Because the two courses share the same content and differ only in their delivery system, we propose that MATH 116E be listed parenthetically with MATH 116 in the course catalog

3. Revise course prerequisites/co-requisites/special requirements:

- 3.1 Current prerequisites
High school Algebra I and II and a satisfactory score on Math Placement Exam; or MATH 096 with a grade of C or better.
- 3.2 Proposed prerequisites/co-requisites/special requirements
High school Algebra I and II and a satisfactory score on Math Placement Exam; or MATH 096 with a grade of C or better. [Student must enroll in MATH 116E if his/her: (1) MATH 096 grade was C; or (2) previous MATH 116 grade was D, F, or W; or (3) Math ACT and MPE scores indicate need for enhanced version.]
- 3.3 Rationale for revision of course prerequisites/co-requisites/special requirements
The proposed prerequisites and special requirements have been a part of the Mathematics Department's placement procedures for nearly a decade. To clarify those procedures for students and advisors, we decided to add to the catalog description the criteria for placement in the enhanced version of College Algebra (MATH 116E).
