- **B.** Master of Public Health, Ref. #152 (Navitas) postponed definitely until December 2011 meeting
  - i. Guest Kinchel Doerner to speak about NAVITAS
  - ii. Confusion about Navitas and the requirements of the program (for example, no GRE, or a difference of scores as compared to other WKU students).
  - iii. Proposals put through UCC in order to have clearer admissions.
  - iv. Concern throughout the process is that Navitas company officials would like to use language that says, "If you come to Navitas, you are more or

less guaranteed admission in any program that you want." However, there could be a number of reasons as to why a student didn't get into the program (full program, etc.). This has always been a concern. With these proposals, that started to precipitate, when Navitas was writing agreements with programs, that didn't come through any formal agreement process, and more or less said that those students were going to be admitted period, in to those programs. He wanted to put a stop to that. They are like any other student for admission. These are supposed to be a tip of the hat to Navitas and waive the GRE for students. The waiving of GRE is implied in these agreements with external recruiters. We are obligated to abide by things like not having to take the TOEFL if that is written in the contract. No program has been asked to take Navitas students if they do not want them. The programs at WKU are in control of their admissions.
