5. Advisory Reports

a. Faculty Regent (Regent Minter)

- Board will meet on March 29
- Big items: budget
- Don't have final enrollment numbers

b. Academic Affairs (Provost Emslie)

- NOTE: This report was moved to the top of the agenda, directly after approving February minutes
 - Must review Campus Mission statement annually, and then send to Regents for approval
 - Current set of revisions are minor, and
 - Would like to have it read on Senate Floor
 - Will send to Senate as information item, reading
 - Move to endorse--approved
- Move student production policy along
 - Provost Emslie: pressure from academic council to move forward
 - Both sides have legitimate points
 - Question from Academic Quality Chair: Could we make it explicit that it will not curtail free speech
 - Provost Emslie: difficult to cover every situation
 - Was written with input from Journalism & Broadcasting
 - Comment: current language could be unclear, misused
 - Comment: we should decide where it is to go, not whether to approve it or not
 - Provost Emslie: Intent is not to curtail free speech
 - Comment: need to insure that language cannot be perceived as curtailing free speech
 - Sent to chair of Academic Affairs and Faculty Senate chair for revision, then bring back to Senate Executive Committee

C. New Business:

1. Policy: Clinical Track Faculty Policy 1.1980 (Posted)

- Chair: one department brought forward new lines
- Offering university-wide what used to be open only for CHHS
- Occurred when nurses were moved to CHHS from University College
- Comment: standard practice
- Approved to go to Faculty Senate

2. Policy: Evaluations of Teaching Assistants Policy 1.3070 (Posted)

- No one currently on Academic Quality Committee currently oversees teaching assistants, so would like Graduate council to review policy
- Comment: trying to unify approaches
- Sent to Graduate Council
- Approved

3. Policy: Academic Program Review 1.4020 (Posted)

- Comment: "Relative or close friend" language is of concern
 - o Could represent slippery slope—someone could be excluded arbitrarily
 - o Someone with whom you share a financial interest?
 - o This conflict policy could be transferred to other policies

- o How would you define "close friends?"
- Chair: what do we want to with it?
- Remove "close friends", replace with "domestic partner and/or relative (e.g., spouse, child)"
- Comment: What about "collaborative projects"? Sounds too broad
 - o Move to remove collaborative project bullet--approved
 - Motions to remove third and fourth bullets also approved
- Policy as amended approved to be sent to Faculty Senate

4. Policy: Evaluation of Faculty Credentials 1.1110 (Posted)

- Chair: related to Provost's presentation at Faculty Senate
- Move to send to Senate--approved

5. Revision of WKU Mission Statement (Posted)

- Forward to Senate as information item
- 6. Handbook Committee Substantive Changes:
 - a. Continuance Committee (Posted)
 - Committee Chair reviewed current revision
 - Chair: if this is what the handbook committee wants, then we will work with this version as presented, and if others wish to reject it, they can
 - o Question: so we're going back to a continuance meeting very year?
 - o Committee Chair: yes
 - Approved to send to Senate for vote on integration into the document

b. Continuance (Posted)

- Comment: may be some discussion in Senate about the role of the Chair in the meeting, but willing to send to Senate as written
- Cmte Chair: These are Provost Emslie's original dates, to avoid bottlenecks (includes "last business day" language)
- o Comment: good, moves the date a little later
- Approved to send to senate

c. Tenure denial date (Posted)

- o Moving dates to conform to previous revision
- Approved
- General comment from Chair:
 - o All of these Handbook changes will be brought to senate separately
 - o Then in the end the corrected Handbook will be approved collectively
 - o Previous report from Handbook Committee requires approval
 - Approved
