New Business

It was agreed to move the election of the 2009/2010 CEBS Curriculum Committee's representative and alternate to the UCC to first on the agenda. The motion to elect them to their respective positions was unanimously approved.

She reviewed the revisions that had been made to the following proposals:

There were no objections to the revisions.

It was agreed by the committee members to make the final selection from these three nominees.
