New Business

From the School of Teacher Education

This called meeting was to address the Courses for the Teacher Leader Master's Redesign.

Sam Evans informed everyone that a reference to the MAE Redesign throughout the proposals will need to be changed to reflect all master's degrees and planned 5th year non-degree programs leading to advanced certification as classroom teachers.

Sherry Powers informed everyone that there are revisions that have been made to all the TCHL new course proposals as shown below:

--All references to the Kentucky Teacher Standards have been removed from the course proposals.

--All references or information about the course critical performances have been removed from each course proposal.

-- The implementation date has been changed on each proposal to Summer 2010.

-- On section 2.2 of each proposal the following information was added or changed to read: "It is estimated that approximately 50 students per term will enroll in the course."

Create a New Course – TCHL 500, Foundations of Teacher Leadership

There was a Berger/Powers motion to approve/second. Janet Applin presented. This course has now been combined with TCHL 510. There were questions, concerns and edits noted regarding if it is a lecture/lab. The motion passed with the understanding that these concerns and edits would be addressed.

Create a New Course – TCHL 530, Curriculum Development

There was a Huss/Schlinker motion to approve/second. Jeanine Huss presented. After some discussion and edits mentioned, the motion passed.

Create a New Course – TCHL 540, Classroom Instruction: Instructional Strategies

There was a Berger/Powers motion to approve/second. Lisa Murley presented. Edits were noted and the motion passed.

Create a New Course – TCHL 544, Classroom Instruction: Equitable Schools for All Stakeholders

There was a Powers/Berger motion to approve/second. Lisa Murley presented. Edits were noted and the motion passed.

Create a New Course – TCHL 548, Classroom Instruction: Classroom Management

There was a Powers/Smith motion to approve/second. Lisa Murley presented. Edits were noted and the motion passed.

Create a New Course – TCHL 550, Student Assessment I: Test Validity

There was a Smith/Powers motion to approve/second. Janet Tassell presented. The course title has been changed to Fundamentals of Student Assessment. Many edits were noted. There was much discussion regarding the prerequisites. It was suggested the prerequisite be TCHL 500 or TCHL 500 could be a co-requisite. The motion passed.

Create a New Course – TCHL 554, Student Assessment II: Standardized Testing

There was a Smith/Berger motion to approve/second. Janet Tassell presented. Edits were mentioned. It was suggested the prerequisites read TCHL 550 or permission of instructor. The motion passed.

Create a New Course – TCHL 558, Student Assessment III: Classroom Tests/Instruments

There was a Powers/Pritchard motion to approve/second. Janet Tassell presented. Edits were mentioned and it was suggested prerequisites read TCHL 550 or permission of instructor. The motion passed.

Create a New Course – TCHL 560, Action Research for Teacher Leaders

There was a Berger/ Whetstone motion to approve/second. Becky Stobaugh presented. Edits were mentioned and it was suggested prerequisites read TCHL 550 or permission of instructor. The motion passed.

Dr. Evans informed the committee members that these courses needed to be to the Education Professional Standards Board by Friday, October 30. These courses will go forward to the Professional Education Council next.
