▪Create a New Course – SMED 400, Applying Middle Grade Science Across Disciplines

There was a Powers/Duffin motion to approve/second. The motion passed.

▪Revise a Program – Master of Arts in Education Interdisciplinary Early Childhood Education Birth to Primary

There was a Powers/Maxwell motion to approve/second. Sylvia Dietrich presented. Some edits were mentioned and noted. The motion passed.
