Course Description:

Applied supervised experiences for clinical and school psychologists. Students must meet minimum hour requirements as specified by the programs. Students are responsible for their own transportation to internship sites.

Prerequisites: Permission of instructor

Purposes and Goals of the WKU School Psychology Internship

- 1. To gain experience in the problem-solving model and with data-based decision-making with all aspects of a school psychologist's role with both regular and special education students. (NASP 2.1, 3.3)
- 2. To provide an opportunity to refine consultation skills with parents, teacher, special service personnel in schools, school administrators, and personnel from other community agencies. (NASP 2.2, 3.3)
- 3. To provide an opportunity to refine psychoeducational diagnostic skills. (NASP 2.1, 2.3, 3.3)
- 4. To gain an overview of the public school as an organization, including its relationship to other societal agencies, its policies, personnel, etc. (NASP 2.7, 2.10, 3.3)
- 5. To develop sensitivity to classroom interactions and factors influencing the classroom atmosphere. (NASP 2.5, 3.3)
- 6. To develop an understanding of the role of preventive and direct mental health services in school programs. (NASP 2.4, 2.6, 3.3)
- 7. To gain experience with an interdisciplinary team approach to child study and the RTI process. (NASP 2.1, 2.3, 3.3)
- 8. To apply principles of research related to diversity in children, families, schools, and communities and ensure equitable service delivery. (NASP 2.8, 3.3)
- 9. To be exposed to the implications of legal constraints and legislative initiatives on school psychology practice. (NASP 2.10, 3.3)
- 9. To provide the opportunity to apply theoretical knowledge to the educational system and problem-solving process. (NASP 2.1, 3.3)
- 10. To practice ethically within the guidelines of NASP and to follow state and federal educational law and local district policies and procedures. (NASP 2.10, 3.3)
