### **Responsibilities:**

This position is responsible for the assessment, development, training and clinical development of clinical staff, to further the execution of our mission. **This position will cover/travel all of our Kentucky divisions and can be located in or any of the Kentucky offices.**

This will be accomplished through the following:

- Based on training and clinical assessments completed in collaboration with staff members and their immediate supervisors, develop and deliver high quality training, clinical supervision, and case consultation to clinical staff.
- Develop and provide clinically oriented training which help staff meet the training requirements of SAFY and meet the needs of clients.
- Provide individual and group clinical supervision and/ or case consultation to clinical staff including but not limited to Family and Youth Specialists, Family Development Specialists, Therapists, and Intervention Specialists. Case consultation and/or clinical supervision provided may occur in addition to supervision and day to day clinical oversight provided by the immediate supervisor.
- Facilitate case consultations and provide clinical coaching to members of the treatment team prior to placement disruptions.
- May assist and consult on development and implementation of treatment programming.
- Provide support for state leadership in maintaining fidelity to clinical and other training models.
- May provide coaching and transfer of learning support for clinical personnel.
- Responsible for documenting all training activity, case consultation, and clinical supervision sessions.
- Responsible for documenting , measuring, and reporting the outcome of any intervention plans developed during case consultation/ clinical supervision.
- Help ensure effective implementation of systems to track training quality and learning progress. Measure training outcomes that can be effectively communicated to SAFY stakeholders.
- Evaluate outcome indicators and analyze trends in order to develop and implement training, case consultation, and clinical supervision plans at the state, divisional, and individual level based on those outcome indicators.

- Graduate Degree in field of social work, counseling or clinical psychology with state appropriate independent licensure

- LISW/LPCC/LCSW/Licensed Clinical Psychologist/LMFT
