- I. FEBRUARY 25, 2010: CALL TO ORDER – Huda Melky**
Called to order at 2:10 p.m.
- II. ATTENDANCE - Huda Melky**
Those in attendance were Huda Melky, Jeff Jones, Leyla Zhuhadar, Vernon Sheeley, Richard C. Miller, Stephen Rowland, John Kessell, Matt Davis and Cindy Smith.
- III. APPROVAL OF MINUTES**
Minutes from the November 19, 2009 meeting were reviewed and approved.
- IV. INTRODUCTION OF STEPHEN ROWLAND**
Huda Melky introduced Stephen Rowland from Parking and Transportation who filled in for Jennifer Tougas.
- V. UPDATE ON STUDENT DISABILITY SERVICES**
 - A.** Matt Davis distributed the handout Student Diagnosis Spring Semester 2010.
 - B.** Huda Melky said some of the policies on the SDS website are outdated. Matt said they are currently updating the website.
 - C.** Dr. Miller asked if the documents are taken down to revise, where will the students go for references of policy and procedures. Matt said links will be provided to let the students know where to go.
 - D.** Leyla Zhuhadar suggested while the website is being updated, to offer the policy in the office based on their case and have them sign a document confirming they have read the policy.

 - D.** Dr. Miller would like Huda to attend the next Administrative Council meeting to discuss the ADA/AA updates.

- B. Currently, Leyla is creating a survey based on our Administrative server. The website will monitor all activities from the EO/AA/ADA office. Sudhir will post the status of web servers on a weekly basis.

- D. Leyla shared that she continues to have students and faculty asking for accommodations instead of going through SDS.
