Program Description: Are you interested in a career in a growing profession that combines patient care, computer technology and management? If so, a career in Health Information Management (HIM) may be for you. The HIM associate degree program prepares the graduate for entry-level employment as a health information technician. Health information technicians are experts in health data collection, analysis, monitoring, maintenance, and reporting activities in accordance with established data quality principles, legal and regulatory standards, and professional best practice guidelines. Graduates of the program are eligible to take the National Registration Examination for the Registered Health Information Technician (RHIT) administered by the American Health Information Management Association (AHIMA).** See HIM careers and advancement opportunities at hicareers.com/careermap/.

Students are required to show current immunizations for:

- Proof of mumps, measles, and rubella immunity by positive antibody titers or two doses of the MMR vaccine
- Varicella immunity, by positive history of chickenpox or proof of varicella immunization
- Diphtheria, tetanus, and pertussis written in the last ten years
- Proof of hepatitis B immunization or declination of vaccine
- Tuberculin skin test and/or chest x-ray within the past 12 months and within 3 months of PPE

All Students are required to purchase:

- Professional liability insurance at an approximate cost of \$35.00 per year
- AHIMA membership at an approximate cost of \$35.00 per year
- Criminal Background Check for approximately \$49.50
 - Students convicted of a felony or assault misdemeanor will not be admitted to the program.
- 7-Panel Minimum Drug Screening for approximately \$55.00

Job Opportunities: Based on skills, education and interests, positions that may be available include: Cancer/other disease Registrar; Clinical Coder; Compliance Auditor; Vocabulary Specialist; Clinical Data Collection and Reporting Specialist; Data Integrity Specialist; Document Imaging Coordinator; Documentation Specialist; Information Access/Disclosure Specialist; Quality Improvement Specialist; Reimbursement Specialist/Financial Services liaison; and Instructor/Trainer. HIM professionals work in a multitude of settings throughout the healthcare industry including hospitals, physician offices and clinics, long-term care facilities, insurance companies, government agencies and home care providers.

Job Growth and Income: According to the Bureau of Labor Statistics, employment of medical records and health information technicians is expected to increase by 22 percent, much faster than the average for all occupations from 2012-2022. This strong demand is due to the rapid growth in the number of medical tests, treatments and procedures that will be increasingly scrutinized by health insurance companies, regulators, courts and consumers. In addition, as the population continues to age, the occurrence of health-related problems will increase. Also, more technicians will be needed to complete the new responsibilities associated with electronic data management.

On top of strong job prospects, competitive salaries also await HIM graduates. According to the Bureau of Labor Statistics, the median annual wage of medical records and health information technicians was \$34,160 in May 2012. The lowest 10 percent earned less than \$22,250, and the highest 10 percent earned more than \$50,200.

Accreditation: The HIM program is currently accredited by the Commission on Accreditation for Health Informatics and Information Management Education (CAHIIM).
