**SPM 200 – Introduction to Sport Management**

The history, principles, and objectives within the sport management profession, overview of sport delivery systems, study of sport as a microcosm of society, and career options within sport organization.

**SPM 310 – Sport Ethics and Morals**

Examines ethical and moral issues that occur in sport organizations and teams.

**SPM 452 – Sport Management and Leadership**

Knowledge of the various skills, roles, and functions of the sport manager, leadership theory and practices as they relate to various sport managerial responsibilities.

**SPM 456 – Advance studies in Sport International Sport**

Course explores the evolving nature of the global sports environment with special focus on major events such as the Olympics, and World Cup. This course will examine cultural factors, political influences, and issues in international sports management.

**RSA 517 – Fiscal Practices in Recreation and Sport**

Course explores financial principles and practices relevant in recreation settings. Topics include economic principles, financial management and organization, income sources, fundraising, pricing, and budgeting.

**RSA 519 – Fiscal Practices in Recreation and Sport**

Course explores financial principles and practices relevant in recreation settings. Topics include economic principles, financial management and organization, income sources, fundraising, pricing, and budgeting.

**RSA 523 – Theory of Recreation and Sport**

Philosophy, theory, and ethics of recreation and sport, including current professional trends in the field.

**RSA 513 – Recreation and Sport Administration**

Course explores Leadership and management of recreation and sport agencies with emphases on strategic planning, policy, human resources, programming, governance, and organizational behavior and culture..

**RSA 554 – Student-Athlete Development**

Develop an understanding of the historical and contemporary issues faced by student-athletes at colleges and universities. Content includes support services guidelines in the areas of academics, personal issues, and career preparation/planning.

**RSA 556 – Governance in Intercollegiate Athletics**

Thorough examination of intercollegiate athletics governing bodies (i.e., NCAA, NAIA, NAAC, NJCAA). Emphasis placed upon governing hierarchy, responsibilities of individual institutions, conference affiliations, and membership requirements

In-depth analysis of NCAA rules and regulations relating to intercollegiate athletics. Topics include ethical conduct, employment issues, amateurism, recruiting, eligibility (academic and general requirements), financial aid, awards and benefits, playing and practice schedules, and enforcement.
