In recent years, because of several serious disasters including natural and people-caused, there has been a significant increase in regulatory mandates for organizations to have a comprehensive emergency management program. These requirements drive the need to have staff that understand the required program elements and have the ability to develop and implement the various plans required for compliance.

In preparation for this proposal, a series of meetings were conducted with college deans, department heads, public-school officials, and representatives from all branches of emergency services at the state and regional levels. All expressed an immediate need that is not currently being fulfilled.

The students completing this program will have demonstrated the ability to assess the preparedness needs of an organization and facilitate the development of appropriate emergency plans for all facets of Emergency Management. Furthermore employers in both the public and private sectors are increasingly creating positions within their organizations for emergency managers and coordinators. This program will help prepare students to meet the requirements of this expanding area of employment.

2. Learning outcomes of the proposed certificate program:

Upon completion of the program, students will:

- Demonstrate a working knowledge of the National Incident Management and Incident Command Systems and properly apply the skills in crisis situations.
- Demonstrate the ability to develop a risk assessment and mitigation strategy for various disaster risks for people, critical infrastructure, and the environment.
- Apply historical and modern contextual analysis of terroristic threats to specific high-risk targets to develop effective prevention and response strategies and tactics.
- Develop comprehensive plans for prevention, preparedness, mitigation, response and recovery phases of emergency management followed with validation utilizing exercises and drills.

3. Rationale:

3.1 Reason for developing the proposed certificate program:

Since the events of September 1, 2001, the focus on readiness for disasters has been growing. In recent years, because of several serious disasters including natural and people-caused, there has been a significant increase in regulatory mandates for organizations to have a comprehensive emergency management program. 1.1. Program title: Emergency Management Disaster Science

Catalog description: The certificate provides students, whether traditional or working professionals, an in-depth acumen related to incident management, risk identification, emergency planning, and emergency management program evaluation. The certificate consists of four core courses EMDS 400 – 403, and the choice of an additional elective course, EMDS 404, or three credit hours of upper division courses in an applicable subject area to complete the program.

SCHOOL OF JOURNALISM AND BROADCASTING NAME CHANGE TO SCHOOL OF MEDIA

REQUEST: Approval to change the name of the School of Journalism and Broadcasting to the School of Media.

<u>FACTS</u>: The faculty of WKU's School of Journalism and Broadcasting have unanimously approved a proposal to change the name of the unit to School of Media. The Director and Dean also support this proposal.

The School of Journalism and Broadcasting is currently home to four distinct programs: Journalism, Broadcasting, Photojournalism, and Film. By mentioning only two of these programs, our current name does not accurately reflect the school's diverse offerings. The current name suggests that the school offers only broadcasting and journalism and that it keeps those areas of study separate.

The film major, the second largest major in the department, is at a disadvantage when it comes to marketing and promotion to potential majors because it is not represented in the current name, the School of Journalism & Broadcasting. The film curriculum does not fall into either of these two categories.

Rather than creating a laundry list of programs in the title, a name that would be more inclusive, the School of Media, was chosen to encompass all four programs in the department. Media or Media Arts are common terms used in the names of departments or schools, such as Indiana University's Media School, that include an array of mass media programs.

In addition to being more inclusive, the proposed name would allow greater flexibility for the future. The name School of Media is broad enough to accommodate new programs or emphases as they develop.

<u>BUDGETARY IMPLICATIONS</u>: This requested name change will not have a significant budgetary impact.

RECOMMENDATION: President Timothy C. Caboni recommends the name be changed from the Department of Sociology to the Department of Sociology and Criminology within Potter College of Arts and Letters, effective July 1, 2019.

UNIVERSITY DISTINGUISHED PROFESSOR APPOINTMENTS

REQUEST: Approval of University Distinguished Professor appointment for Dr. Bruce Schulte, Professor of Biology, effective July 1, 2019.

<u>FACTS</u>: Following a review of nominations, below is a faculty member who has been recommended by the University Distinguished Professorship Selection Committee and the Provost to be awarded University Distinguished Professor status effective July 1, 2019.

Dr. Bruce Schulte joined WKU in 2009 as Head of the Department of Biology. As an active behavioral ecologist, conservation behaviorist, scholar, researcher and mentor, Dr. Schulte continues to enjoy a distinguished career. He authored/co-authored 28 peer-reviewed publications between 2010-2018. The majority of which include student co-authors. Additionally, Dr. Schulte's scholarly activities include published editor-reviewed papers, book reviews, and general public oriented articles.

Dr. Schulte has presented or been a co-author (primarily as a student research mentor) on 57 professional presentations with another 12 invited talks at universities or zoological institutions (e.g., University Louisville, Purdue University, University of Vermont, Florida International University, Lincoln Park Zoo, Miami Zoo), and served as the keynote speaker at two professional meetings (Elephant Wellness Workshop in Jacksonville FL; Elephant Managers Association in Nashville TN).

As Professor of Biology, Dr. Schulte believes students best learn by doing. As a result, he incorporated innovative and effective high-impact teaching and learning strategies in his courses. Examples include extensive writing, group and individual activities, the creation of a team video on an environmental problem and potential solutions and presentations.

Dr. Schulte serves as an Associate Editor for the journal *Behavior*, and has reviewed 70 manuscript submissions over the past ten years. Previously, Dr. Schulte served as lead editor on the published volume *Chemical Signals in Vertebrates 13*, and served as co-editor on a set of articles on conservation behavior published in *Animal Behavior*.

Dr. Schulte's commitment to service and productivity is underscored by his leadership of the Department of Biology and service as a Co-Advisor of the WKÙ Strategic Plan: *Climbing to Greater Heights*. Throughout his career, Dr. Schulte's leadership style and acumen focuses on collaboration and vision with the ability to create shared goals and make challenging decisions.
