SUPPLY CHAIN MANAGEMENT GRADUATE CERTIFICATE

REQUEST: Approval of a Graduate Certificate in Supply Chain Management through the Gordon Ford College of Business.

FACTS: The Graduate Certificate in Supply Chain Management supports two of the major areas included in WKU's Climbing to New Heights Strategic Plan: Serving as a Regional Lighthouse and Providing Continuing Education. Our work in designing and delivering the Supply Chain graduate certificate allows us to play an important role in research, discovery, and serving as an information repository for the growth and development of this field in our region.

We have worked with stakeholders such as area industry leaders, former alumni, and quasi-government organizations to develop needed curriculum and credentials to the existing workforce. In this regard, we are contributing to the lifelong learning of members of the regional community.

It is expected that shifting demographics and new forms of industry disruption will create significant challenges for upskilling in this field. This certificate offers skills needed current job market opportunities and will assist our regional stakeholders in building a talent pipeline with utility well in the future.

South Central Kentucky is located within a day's drive of 60% of businesses and individual consumers in the United States. As a result, our region has a well-established manufacturing base, represented by several industry types including aluminum, automotive, food production, metals, and other consumer goods. Manufacturing anchors our regional economy, with 17% of our jobs (three times the national average) in this employment sector.

Supply chain management has emerged as a key driver of value creation in such organizations and there is demonstrated open job and projected demand for roles such as Supply Chain Analysts, Logistics Analysts, Production Control Analysts, Supply Chain Managers, Logistics Managers, Procurement Analysts, Logisticians, Procurement Managers, and Purchasing Managers.

A quick search for "Supply Chain Management" open positions on Indeed.com indicated 366 mid-level and 74 senior-level positions within 100 miles of Bowling Green. Mid-level positions pay a range of 60-90k, while senior roles earn 90k+. Demand projections indicate .7% growth for the next ten years in roles common in the field in the WKU Service region (Jobs EQ, September 2021).

Competencies needed and developed through the certificate include both hard and soft skills identified by professional supply chain organizations (APICS). Hard skills include technical competencies such as supply chain synchronization, international regulation, strategic sourcing and supplier relationships, and executing, planning, scheduling, and control. Soft skills include problem-solving, decision-making, navigating complex relationships, critical thinking, decision making, and customer focus.
