#### **General Education Committee**

Dr. John Bruni said the General Education Committee has received two research reports evaluating different aspects of the UC101 course and its continuation. Those reports will be placed on Dr. Bruni's web page and urged that each Senator read these reports before the February meeting when this course will be discussed, and a recommendation will be brought forward. Next, Dr. Bruni said all Department Heads have received a memo regarding a review of the General Education courses, and paperwork will be sent out next week for the Department Heads to review and evaluate.

Dr. Bruni moved approval of a **new course**:

RELS 103 Religions of Asia to be placed in General Education Category E

Darlene Applegate noted that this course has not been approved by the Curriculum Committee.

Dr. Dietle said the approval of this course will be contingent upon approval of the Curriculum Committee, and called for a vote.

The motion was seconded. The motion carried.

#### **Faculty Welfare and Professional Responsibilities Committee**

Katrina Phelps reported in the absence of Dr. Ernst.

Dr. Phelps said the Committee was working on two surveys, one that will be given to Department Heads to track position openings, new hires, and people leaving the University. The other survey is a faculty survey to gather data on what faculty view as priorities in their workplace satisfaction with categories including advising, teaching, creative and research activities. Also there will be a section on benefits to ask about healthcare, salary, raises, etc., and a section regarding the evaluation process, including tenure and promotion standards and decision-making at departmental, college, and university levels. Both surveys will be disseminated in February.

Dr. Dietle reminded the Senate that at the next meeting of the University Senate, the General Education Committee will bring forward a recommendation regarding the continuation of UC101. He urged each Senator to read the two research reports before the February meeting.
