Election of Officers for 2004-05

Chair:

Chair Smith opened the floor for nominations for the 2004-05 Chair of the University Senate

Robert Smith nominated James Berger. Nezam Iraniparast nominated Sherrie Serros.

Senator Patricia Minter moved that nominations cease. The motion was seconded. The motion carried.

Senator Uta Ziegler asked if each nominee accepted his or her nominations. Each nominee accepted. Next Senator Ziegler asked each nominee to make a statement on how they would view their duties as Chair of the University Senate.

Senator Serros said this is her third year as a Senator, and as Chair she would try to have things run more efficiently. She said she is a big proponent of openmeeting laws and believes the agendas should be out much quicker than they have in the past, and that minutes of the meetings should be posted well in advance of

the meetings. Next, she said the Senators that do not attend Senate meetings should to be notified that their absences are affecting governance. Senator Serros said that prior to coming to WKU, she served as Chair of the Faculty Senate at the University of Wisconsin - Platteville for three years.

Senator Berger said he served as Vice Chair of the University Senate this past year, and this will be his second year serving as Senator. He said in thinking about his role as Chair of the Senate, he would like to emphasize and strengthen the role that the faculty plays in the University Senate. He said he has seen reluctance among faculty members to participate, and when faculty members are here, we have wonderful discussions, he said he would like to continue encouraging this, and also wanted to get more people who do not come to the meetings to get involved in the process. Senator Berger said he wanted to start outreaching to more groups, first students, the major reasons he feels faculty members are here at the university, and then to our constituents. Senator Berger said he wants to involve students more, as well as working to involve the administration in more than adversarial roles that has been developed in previous years. He said he has been in several leadership positions, therefore has gotten used to working towards developing consensus and taking leadership when necessary. He said he would like to shorten the time of the meetings and improve communication between the University Senate and faculty. He said he believes he will be able to work towards that end. He said his experience as Vice Chair has helped him develop the experience necessary to take leadership of this body and bring it forward.

Next a secret ballot was taken for the Chair of the University Senate.

Senator Serros was given 28 votes and Senator Berger was given 18 votes.

Senator Sherrie Serros was named Chair of the University Senate for 2004-05.

Vice Chair:

Chair Smith opened the floor for nominations for Vice Chair.

Sherrie Serros nominated James Berger. A motion was made and seconded that nominations cease

Senator Berger was elected by acclamation.

Secretary:

Chair Smith opened the floor for nominations for Secretary.

Senator Darlene Applegate nominated Suzie Cashwell. A motion was made and seconded that nominations cease.

Senator Cashwell was elected by acclamation
