  - 1. Lectures, readings, and assignments will introduce students to the basic formal elements, techniques, concepts, and vocabulary of the discipline of New Testament Studies.
  - 2. Lectures, readings, and assignments will introduce students to the various ancient literary genres that are found among the books of the New Testament (e.g., "Gospel"/narrative, "Epistle"/letter, and "Revelation"/apocalyptic), as well as subgenres (e.g., poetry, miracle story, creedal statements), and to diverse and appropriate strategies for reading these genres in their historical setting.
  - 3. Lectures, readings, and assignments will introduce students to the social, cultural, and historical contexts of the New Testament books and how these contexts have influenced these books.
  - 4. Lectures, readings, and assignments will introduce students to the notion of a "canon" of Scripture i.e., "the New Testament" and to the ways in which the New Testament books (or portions of them) have, both individually and collectively, served as one important factor in shaping larger social, cultural, and historical contexts.
  - 5. Lectures, readings, and assignments will introduce students to the ways in which the New Testament books have contributed to the understanding of enduring and contemporary issues of human experience questions such as the existence of God, what it means to be human, and how one should live.

- A. An essay question will be added to the final exam in the course. The question will require students to
  - 1. Demonstrate familiarity with the basic formal elements, techniques, concepts, and vocabulary of the discipline of New Testament Studies.
  - 2. Demonstrate familiarity with at least one ancient literary genre and/or subgenre that is found among the books of the New Testament, and with at least one strategy for reading this genre in its historical setting, and to be able to use this knowledge to distinguish between various kinds of evidence by identifying reliable sources and valid arguments.
  - 3. Demonstrate how social, cultural, and historical contexts of at least one potion of the New Testament have influenced it.
  - 4. Demonstrate, through the notion of a "canon" of Scripture, how at least one portion of the New Testament has served as an important factor in shaping larger social, cultural, and historical contexts.
  - 5. Demonstrate how at least one portion of the New Testament has served as an important factor in contributing to the understanding at least one enduring and contemporary issue of human experience.
- B. At the end of the semester to be assessed, the answers of 30% of the students in each section of the course will be selected at random for assessment.
- C. At least two faculty members will assess each answer. The names of the students and of the instructors for the sections will be eliminated before the assessment takes place.
- D. Answers will be given one of four designations.
  - 1. Excellent The student has demonstrated proficiency in all outcomes.
  - 2. Good The student has demonstrated proficiency in most outcomes.
  - 3. Fair The students has demonstrated proficiency in some outcomes.
  - 4. Poor The students has demonstrated proficiency in no outcomes.
- E. The results will be tabulated and given to the Department Head.
- F. The Department Head will convene the relevant faculty to review the results and to determine what steps, if any, need to be taken in order to improve the instruction in course.
