  - Reminded group of parliamentary procedures.

  - Thanked everyone for caucuses. Asked for anyone interested in Academic Quality, Colonnade, and UCC still had an at-large position.

  - Encouraged someone to volunteer to chair the Academic Quality committee.
- 2. <u>Budget and Finance, Eric Kondratieff, Chair</u> E. Kondratieff (33 y, 0 n, 0 abs) <u>approved</u>
  - E. Kondratieff: the report includes a summary version of the meeting with Todd Stewart, the WKU Athletic Director. Provided clarification on statements regarding HAF meeting commitments.
- 3. Colonnade/General Education, Stacey Forsythe, Chair (No Report)
- 4. <u>Faculty Welfare and Professional Responsibilities, Kate Horigan, Chair</u> K. Horigan (30 y, 0 n, 0 abs) <u>approved</u>
  - Survey was completed last week. There were 319 responses.
- 5. Graduate Council, Dana Sullivan, Chair D. Sullivan (15 y, 0 n, 2 abs) approved
- a. JUMP Policy Proposal D. Sullivan (15 y, 8 n, 3 abs) approved
  - R. Blankenship: The policy has been in the works for over three years. It tries to meet multiple needs.
  - J. Cipolla: Relayed comments from PCAL program coordinators opposed to reducing the possible number of JUMP hours.
  - A. Olson: Comments were compiled from all program coordinators in PCAL. Seeking to separate out the number of double-counted credits from the total number of credits. It changes the JUMP from being a 4+1 and might possibly harm recruitment of students with scholarships.
  - M. Price: Believes there are other ways to abide by SACS rules without negatively impacting the JUMP programs.
  - K. Atkinson: Expressed concern regarding JUMP programs and what separates undergraduate from graduate programs.
  - B. Fischer: 2 students in history from Fall data. 217 overall students in JUMP programs.
  - R. Koodali: There are 87 graduate students in spring who enrolled from JUMP programs. Over time, 196 dropped out, 314 awarded degree, 87 currently in program.
  - B. Fischer: SACS asked the question in 2017 regarding program's covering the learning outcomes for the undergraduate and graduate program.
  - L. Elkind: Asked was accreditation tied to a university-wide policy related to this?
  - B. Fischer: SACS
  - M. Gardner: Asked about the non-duplicated hours. What is the issue with limiting these hours?
  - R. Blankenship: No more than 25% of the credits should be taken at the undergraduate level.

- M. Gardner: Asked about courses that include 42 hours. Could the guidance be 25% instead of specific number of hours.
- E. Kondratieff: The math does not work at all. 12 hours would require a 48-hour program. If a student enters with 30 hours from high school, they have a four-year scholarship, why can't they take 18 hours during that fourth year?
- R. Blankenship: The 18 hours gets to the integrity of the graduate program with the coursework taken at the graduate level.
- R. Koodali: It is in our best interests with SACS to have a policy. There is no information in the graduate catalog regarding JUMP. They are currently in MOAs and creates confusion for students, faculty, and advisors. It is in the best interest of the university to publish this information in catalog and make it transparent. The numbers have come with great analysis and are in keeping with our peers.
- K. Atkinson
- M. Price: No numbers on the scholarship, but the numbers university-wide are high and students in JUMP program are probably high. We do not limit the number of dual enrollment courses that students can bring to WKU. Read guidance regarding JUMP programs from SACS document related to falling far short of 150 hours and allowing any student to participate.
- B. Fischer: The standards do not state a number of hours, but conversations with SACS shared a range.
- L. Elkind: Will this jeopardize our accreditation?
- R. Koodali: We did contact our SACS representative. The guidance given to us was double counting nine hours would probably be questioned by the peer review committee.
- E. Kondratieff: Could there be an opportunity for greater flexibility? He shared the high quality of students that he has been able to teach at WKU.
- D. Clark: His colleagues and Ogden College were urging him to vote on this compromise. He asked if scholarships are the issue, could WKU change scholarship funding?
- K. Atkinson: We should come back after a year to review the impact. B. Fischer asked to allow everyone to get the policy fully implemented and then come back to review. E. Kondratieff: We would at least like to follow up with the new policy.
