### 1. Faculty Regent, Shane Spiller

- Met January 20-committee meetings. They will meet again on March 3. Four Regents attended Kentucky Chamber event in Lexington last week. The President shared the increased retention data with Regents. They have sent emails praising faculty/staff for this work.
- M.McKerral asked if there were any data related the increase in retention. S. Spiller shared the one strategy that has been credited has been the LLC because retention rates were higher among LLC participants. B. Fischer mentioned LLCs, expansion of some advising, FirstGen efforts. M. McKerral asked about opportunities to expand LLC efforts across campus. B. Fisher shared they are looking for ways to expand to include all Freshmen.
- K. Atkinson asked about the current legislation related to capping tuition. B. Fischer shared the challenges predicted with this policy, especially with CPE discretion on increases in tuition. M. McKerral: need for more faculty and students on the board.
