Update from Dr. Rheanna Plemons, Assistant Provost for Accreditation and Assessment

- First, thanks to the committee for being so accommodating to the pilot that I shared last month.
- **Assessment** – Last week, I emailed all Department Heads, Deans, and Directors asking them to share Colonnade Assessment Information with the individuals who coordinate the Colonnade assessment process in their department. The email contained information for three information

sessions on Explorations Assessment that I conducted last week. Department heads for Foundations Courses were contacted individually with the opportunity to either meet with me or watch an informational video on this year's assessment process. Here are some key points:

- Foundations and Explorations Courses will be assessed using Fall 2025 data. Departments will be asked to self-assess how well their general education courses are performing in the assigned category. Assessment will be on templates that will also include a reflection on the Kentucky Graduate Profile Competency assigned to the category. Completed templates and artifacts for Foundations and Explorations are due on January 30. (If the Committee is willing, we can review some of the Connections artifacts submitted from 2023-2024 to gather some baseline data.)
- Connections courses will be assessed using Spring 2025 data. Templates and artifacts should be collected by May 30. (If the Committee is willing, we can review some of the Connections artifacts submitted from 2023-2024 to gather some baseline data.)
- I plan to work with the Colonnade Committee to look at information I receive from Fall 2025. I'm hoping this will allow us to pinpoint needs for Colonnade going forward.

- I am currently attending the Assessment Institute in Indianapolis gathering ideas for general education, competency-based, and program assessment. I would like for us to think about how we can update the Colonnade assessment process to be more transparent through documenting the process.
- **Syllabus Statements:** Syllabus statements are not on the Syllabus Information website along with the ASL Templates and Resources website and the Colonnade website. In my email to department heads, deans, and directors, I asked for statements to be included in Spring 2026 syllabi. However, it might be helpful for the Colonnade Committee to communicate this with their colleagues.
