

Laura Goad Turner-Allen County Schools SKyTeach Scholarship

Guidelines for the Laura Goad Turner SKyTeach Scholarship

1. The Laura Goad Turner Charitable Foundation SKyTeach Fund was established as perpetual trust within the College Heights Foundation in 2009, by a gift made by the Laura Goad Turner Charitable Foundation.
2. Recipients of the Laura Goad Turner SKyTeach Scholarships are to be full-time students at Western Kentucky University and enrolled in the SKyTeach program.
3. First preference must be given to scholarships for participants of the SKyTeach Program who are
 - a. graduates of Allen County-Scottsville High School or
 - b. students who have matriculated through Allen County-Scottsville High School to the Gatton Academy at WKU prior to graduation.
4. Recipients must have a minimum high school GPA of 3.0 or a minimum college cumulative GPA of 2.75.
5. Prior to receiving the scholarship, selected recipients must sign a Code of Conduct policy encompassing how they represent WKU, the LGTCF, and the SKyTeach Program.
6. If no student meets the above criteria, available funds may be used for the following areas of the SKyTeach Program:
 - a. Internships in Allen County and Scottsville
 - b. Programming in middle and high school Math and Science classrooms in the Allen County-Scottsville School District, conducted by SKyTeach participants. This programming will be continually reviewed and developed by the WKU SKyTeach representatives and representatives of the Allen County-Scottsville School District.
