Announcing the Master of Arts in Social Responsibility & Sustainable Communities at Western Kentucky University

The Master of Arts in Social Responsibility & Sustainable Communities is an interdisciplinary program of study that provides students with the tools to lead communities toward social justice and sustainability. It is designed especially for students inclined toward the humanities, social sciences, and related fields. Students take a core set of courses that provide interdisciplinary grounding in social justice and sustainability, policy issues, community-building, and community-based research. Students may focus their elective courses on environmental sustainability, gender & women's studies, leadership, non-profit, or other areas of interest—depending on availability of courses and in consultation with their advisor. Students in the MA in Social Responsibility & Sustainable Communities will cultivate the skills and knowledge necessary to encourage and lead for cultural, political, and social change for more just and sustainable communities.

The Master of Arts in Social Responsibility & Sustainable Communities is a unique experiential learning program, an interdisciplinary degree focused on social justice, community, and sustainability. As a student in this program, you will systematically study the root causes of problems, engage in action research, and identify possible solutions. You will have the opportunity to meet community members engaged in work relevant to theories and practices learned in the core courses and the electives. Your master's program will culminate in a conference-style symposium where you will share your own research and respond to that of your peers."

Objectives: Through this MA program, you will be able to

- examine a range of disciplinary perspectives on social justice;
- analyze the interrelationships of issues and interlocking systems associated with social organization and community development;
- examine the practical and theoretical principles of sustainability and how to apply them to diverse situations and communities throughout the world;
- analyze the power relationships (gender, race, age, class) that historically surround social
 justice and how these may be changed or augmented to increase social equality and
 equity; and
- apply the principles of community organizing and be able to effectively utilize them in a variety of communities.

The MA in Social Responsibility and Sustainable Communities is comprised of a thesis and a non-thesis option. Both options require 18 hours of Core Courses plus electives, and including

the thesis option, for a total of 33 hours; students are required to be in attendance during the campus-based SRSC 590 Sustainability Symposium.

Students may choose to write a thesis for six hours of credit (SRSC 599), the equivalent of two courses, or to complete six hours of additional electives for a non-thesis option.

Application Procedures

NO GRE REQUIRED!

However, due to the absence of a GRE, all remaining admission documents are extremely important, especially the first three. Admission documents required:

- official copies of all undergraduate and graduate transcripts
 - o If you have weak spots (e.g., a weak beginning or a failing semester) be sure to address them in your statement.
- statement of purpose
 - o Let us know who you are; why this program is right for you.
 - o Length is up to you, but we are eager to learn about you, so don't hold back.
- two letters of recommendation
 - o Seek out references who can attest to your ability to do graduate-level work.
- resume

Statement of Purpose

Discuss your personal, professional, and/or academic preparation for graduate study and how the Master's program in Social Responsibility and Sustainable Communities will fit into your professional development. Address any weaknesses in your prior educational experience. Be sure to give us a strong sense of who you are.

Letters of Recommendation

Please have those who write the letters of recommendation on your behalf address your potential for graduate study, and in particular, this program of study. It is better to have former professors write letters than friends; however, we recognize that some candidates have been out of school long enough to make this unfeasible. In that case, supervisors who have good knowledge of your intellectual capacities can write your letter—but do try to include at least one letter from someone who has seen your writing and critical thinking.
