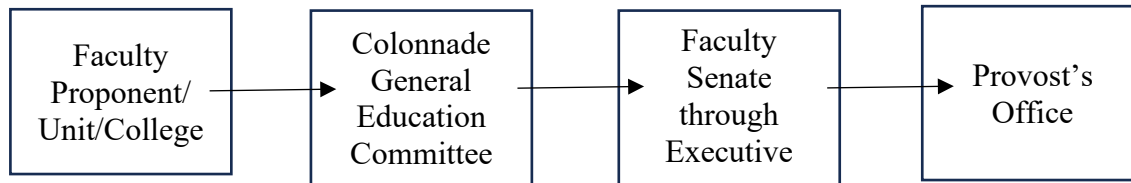

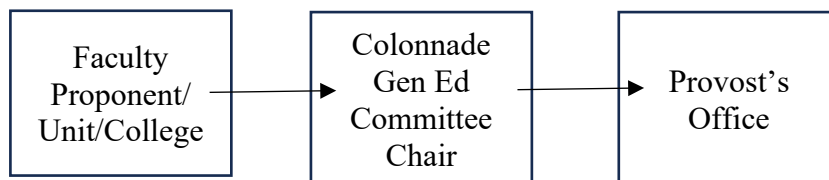

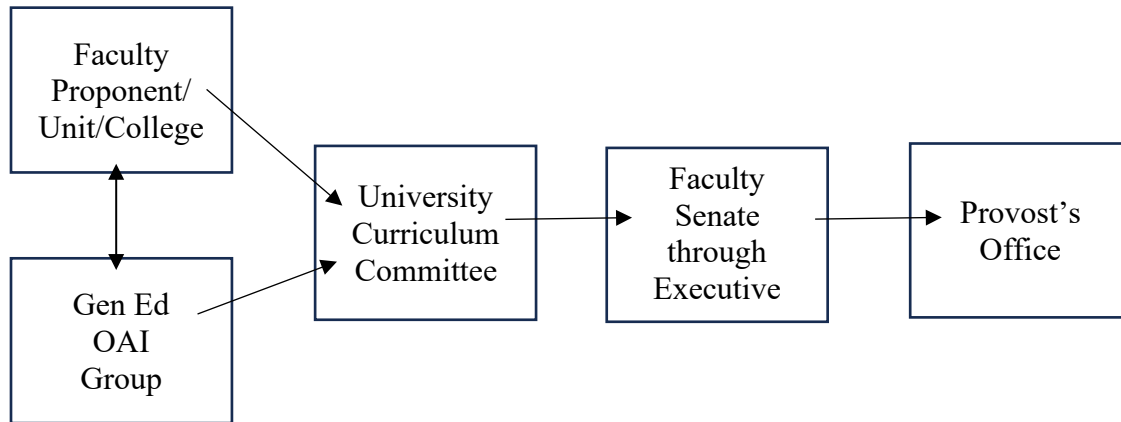

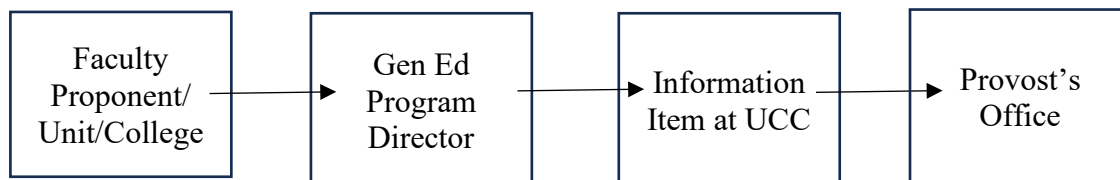

General Education Oversight, Assessment, and Improvement Group (Gen Ed OAI)

- **Gen Ed Program Operations from Gen Ed OAI Group to UCC**
 - Change to the general education program (e.g., course categories, learning outcomes, and implementation guidelines)
 - Removal of existing courses from program (e.g., not offered regularly or not meeting learning outcomes)
- **Oversight – Gen Ed OAI group only makes recommendations to UCC and Units/Colleges**
 - **To UCC: Review course proposals to ensure courses meet program learning outcomes and comply with assessment requirements (Endorse/Not endorse to UCC; final decision resides with UCC)**
 - To Faculty/Unit/College: Evaluate assessment data to recommend course review
- New curricular assessment and improvement duties not currently performed by CGEC
 - Review program assessment data to propose changes to structure of program relative to university mission
 - Systematically evaluate program relative to CPE and SACSCOC compliance requirements

Full vs. Expedited Workflow Review

Expedited Review Workflow

Expedited review is available for the following curriculum proposals:

- Program Deletions or Suspensions
- Reactivation of Programs with no impact on other departments
- Course Deletions/Suspensions with no impact on other departments
- Course Prerequisite/Corequisite Changes, if no impact on other departments
- Schedule Type Revisions
- Course Prefix Changes
- Course Descriptions Updates (No content changes)
- Number Changes without a Level Change (i.e., lower-level to lower-level or upper-level to upper-level)
- Non-Substantive Course Title Changes (addition/removal of Roman Numerals, changing abbreviations, no course description update)
- Repeat Limits (consult the Registrar before making the change)
- Program Modality
- Temporary Course Proposals ([see details below](#))
- CIP Code Changes (Requires CPE approval and a separate form)
- Program and Course Learning Outcomes (if non-substantive or required for accreditation)
- Four-Year Plan Course Sequence Adjustments
- Program application materials, deadlines, and/or changes to the applicant review process (Graduate Level Only)

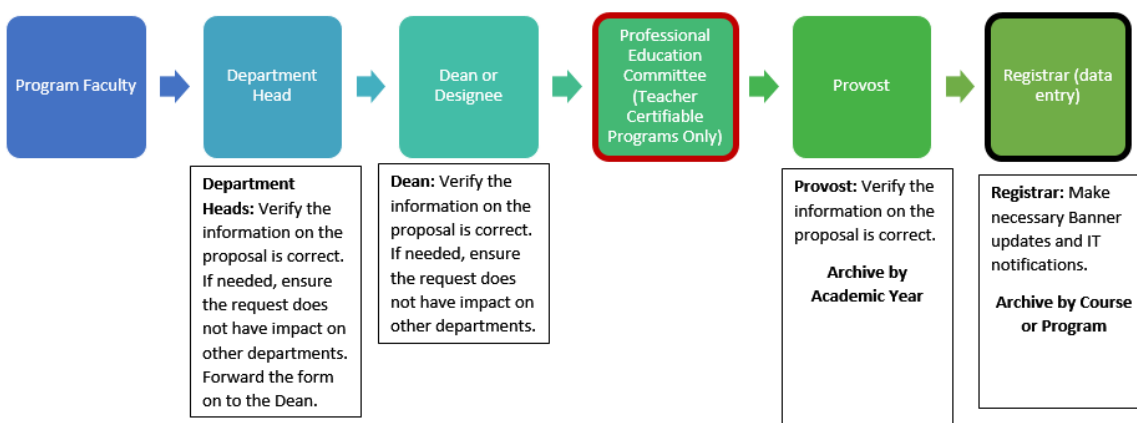
The purpose of the expedited review is to allow programs to make non-substantive changes that do not impact other departments. Revisions to courses are intended to be single-course revisions that do not affect other departments. **Multiple revisions to a course** require a full review.

Temporary courses will follow the established approval process:

- UG courses: Dean> UCC> Provost
- GR courses: Dean> Exec Dir Grad Studies> Provost

“Impact on other departments” is defined as affecting another department’s majors/minors, prerequisites, or corequisites.

Full Review Workflow

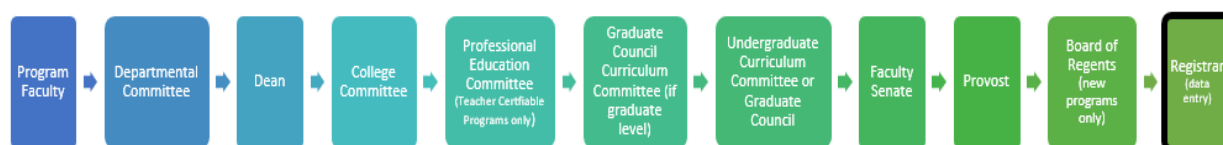
Full review is required for the following curriculum proposals:

- New Majors, Minors, or Certificate Programs
- Program Revisions
- New Courses
- Multiple Changes to a Course
- Extension of a Temporary Course
- Course Title Changes
- New Policies
- Course Suspensions/Deletions (if impact on other departments)
- Student Learning Outcome Updates
- Course Prerequisite/Corequisite Changes (if impact on other departments)
- Number Changes (level changes only)
- Revised Course Descriptions (with substantive content change)
- Credit Hour Revisions
- Establish/Delete Equivalencies
- Policy Revisions
- Request Exemption for Policies
- Course Revisions
- Substantive changes to program or course learning outcomes

Note: Colleges can initiate curriculum changes for programs.

Note: The below internal workflow does not include SACSCOC and CPE approvals.

Note: The Board of Regents Academic Affairs Committee must approve prior to full BOR approval.
